TOPIC

Wills & Intestacy: Any Wise Choice?

It is imperative in any legal discussion to begin with a basic overview of the subject matter. The principal legislation governing testate succession in Nigeria is the Wills Act of 1837. Although common law and equity play a significant role, it is perhaps worthy of note that various states in Nigeria have their respective laws which reflect the unique jurisprudence therein. Other important sources of the law of succession include Islamic law, native law and custom.

However, notwithstanding the existence of a legal framework for the administration of testate and intestate succession, in our society at large, the appropriate mechanism for the settlement of one's property after death, whether a will was made or not, can often occasion conflict. There have been instances, too many to mention, of arduous litigation regarding the inheritance of assets and properties post-mortem. A pungent example is the case of renowned lawyer, F.R.A. Williams (SAN) who died without leaving a will, which led to several law suits which raged on decades after his passing. This scenario and many others similar to it bring to the fore the consequences of intestacy. The example cited also goes to show that the issue of intestacy remains widespread even amongst lawyers. In the same vein, there are instances of improperly or inconclusively drafted wills which leave room for acrimonious contestation that leaves a sour taste in the mouths of all involved and call for timely intervention by legal practitioners.

To avoid full intestacy or partial intestacy, a testator must devise all his assets and properties in a valid will. For a will to be valid, the testator must possess testamentary capacity to dispose of his estate. Additionally, the will must be made voluntarily without any element of undue influence. It must also be in writing and duly executed in accordance with the relevant

legislation. In instances where there is no will, whether owing to the choice of the deceased to submit to Islamic law or the native customs and traditions by which he or she is bound, it is important to clarify the issues which impact on the proper resolution of rights and obligations arising from the disposition of the deceased's assets. In this light, what can be done to ensure that the menace of disputes arising from wills and intestate succession is avoided? Is there any wise choice?

Bank Plc. She has contributed numerous scholarly articles to legal publications, journals and books and is a regular resource person at seminars, workshops and conferences.




